



SUBSTITUTIONS FOR CCS 1001 for LEGACY STUDENTS (effective Fall 2023):

LEGACY STUDENTS - Substitutions for CCS 1001 if required in the **General Education Requirements**, 7th Gen Ed category meeting Continued Learning/Info Literacy:

If a student is eligible for an exemption according to the [CCS 1001 approved exemption](#), the CCS 1001 course would be able to be substituted with any approved General Education course that fulfills ANY General Education Core Category (see below). See [General Education Courses List](#).

- Math 100 or higher
- Arts & Humanities
- Scientific Knowledge & Understanding
- Scientific Reasoning
- Social & Behavioral Sciences
- Historical Knowledge
- Oral Communication
- Written Communication II
- Continued Learning/Info Literacy

LEGACY STUDENTS - Substitutions for CCS 1001 if required in the **Framework30 (FW30) Requirements**:

- *Legacy TAP students will follow the approved exemption process for CCS 1001 and can substitute a previously taken course if:*
 - *They have previously taken a Continued Learning & Information Literacy (CL/IL) or Critical Analysis/Logical Thinking course (CALT), or*
 - *They have completed Section B of their previous FW30 requirements*
- *If a Legacy TAP student is eligible for the CCS 1001 exemption, but has not previously taken a CL/IL, CALT or completed Section B of their previous FW30 requirements, CCS 1001 is recommended or any approved CL/IL course to meet the CL/IL requirement.*

- *Students who have completed the Continued Learning & Information Literacy competency (either directly or through one of the above substitutions) but have not completed CCS 1001 or an equivalent student success or first year experience course are encouraged to enroll in CCS 1001 if an elective course is available in their program.*

If a student is eligible for an exemption and according to the [CCS 1001 approved exemption](#), a Program Coordinator would approve a substitution of another course for the program (non-general education) requirement. The course must not be fulfilled elsewhere in the program requirements.

SUBSTITUTIONS FOR CCS 1001 for TRANSFER STUDENTS (effective Fall 2023):

TRANSFER STUDENTS - Substitutions for CCS 1001 if required in the [General Education Requirements](#)

If a student is eligible for an exemption according to [CCS 1001 approved exemption](#), the course substitute would need to fulfill one of the General Education categories under the 7th requirement. The course substitution would be an approved course from the [General Education Course List](#). The course must not be fulfilled elsewhere in the general education requirements.

TRANSFER STUDENTS - Substitutions for CCS 1001 if required in the [Framework30 Requirements](#)

For the Transfer Ticket programs, CCS 1001 is required under the Continued Learning & Information Literacy Requirement.
