4. FIRST AID MEASURES

Eye Contact: Immediately flush with clean, cool water for 15 minutes and if irritation persists, get medical attention.

Skin Contact: Immediately wash skin with soap and plenty of water while removing contaminated clothing, for at least 15 minutes. If irritation persists, get medical attention. Launder contaminated clothing before reuse.

Inhalation: Remove victim to fresh air. If individual experiences nausea, headache, dizziness, has difficulty in breathing or is cyanotic, seek medical attention. If not breathing, give artificial respiration via a suitable mechanical device such as a bag and mask. Do not use mouth-to-mouth resuscitation.

Ingestion: Do not induce vomiting. Rinse mouth with copious quantities of water first and get immediate medical attention. Drink several glasses of water. Never give anything by mouth to an unconscious person. If vomiting occurs, keep airways clear.

Note to Physician: There is no specific antidote. Treatment of overexposure should be directed at the control of symptoms and the clinical condition of the patient. Aspiration may cause lung damage. Probable mucosal damage may contraindicate the use of gastric lavage.

Most Important Symptoms/Effects:

Eye Contact: May cause irritation. May cause corneal damage with prolonged contact.

Skin Contact: Prolonged contact may cause irritation.

Inhalation: Vapors or mists may irritate respiratory passages.

Ingestion: May be mildly toxic. May cause gastrointestinal irritation. Do not take internally. May cause nausea, vomiting, and/or diarrhea.

5. FIRE FIGHTING MEASURES

Suitable (and Unsuitable) Extinguishing Media: Any media suitable for the surrounding fire.

Specific Hazards Arising from the Chemical: Product may be irritating to the eyes, skin, and respiratory system. Closed containers may rupture (due to buildup of pressure) when exposed to extreme heat. If evaporated to dryness, some product residuals may burn. Thermal decomposition may release oxides of carbon and sulfur. Organic acids.

Special Protective Equipment and Precautions for Fire-Fighters: Wear self-contained breathing apparatus and full turn-out gear. Approach fire from upwind direction. If possible, move containers away from fire. Cool fire exposed containers with water spray. If containers rupture or leak, product may evolve irritating or toxic gas under extreme heat. Contain runoff.

6. ACCIDENTAL RELEASE MEASURES

Spill Containment and Clean-up Instructions:

Wear suitable protective equipment found in section 8. Small spills may be flushed with copious quantities of water, preferably to a sanitary sewer or waste treatment facility. Larger spills may be absorbed in sawdust or other absorbent and sweepings disposed of in an approved landfill. The area may then be flushed with copious quantities of water. Floor may be slippery; use care to avoid falling. Avoid release of this product into the environment to prevent contamination of soil, sewers, natural waterways and/or groundwater. Handling and Storage:

Store in a cool, dry, well ventilated area, between 10°C and 49°C. Keep containers tightly closed when not in use and follow all recommended safety precautions when handling the material. Keep out of sun and away from heat or open flame. Keep away from incompatible materials. See Section 10 for incompatible materials. Do not allow to freeze.
