

Requirements to run for SGA Vice President

1. Shall have been a voting member of the SGA for at least one (1) semester.
2. Shall have a minimum GPA of 2.5.
3. Shall be carrying minimum six (6) academic credits.
4. Shall present a petition of one hundred (100) signatures from the student body, to the SGA excluding SGA members. (see petition attached)
5. Shall submit an essay to the SGA advisors explaining why they want to run for Vice President

Responsibilities of the SGA Vice President

As stated in the SGA Constitution: Vice President

1. Shall assume the duties and responsibilities of the President during the absence of the President.
2. Shall serve as an ex-officio member of all committees.
3. Shall act as the liaison between all committees and the President.
4. May not be an officer of any other organization on campus.
