Release arrangements will be determined through mutual agreement between governance members, their direct supervisors, and relevant deans. The release for governance-related responsibilities is aligned with statewide governance duties and obligations.

Professional/Classified Staff: Release, Comp Time, EA Contract/Overtime, Hiring an EA

Release is adjustments made to work responsibilities and expectations that do not adversely impact the relationship between an elected governance representative and their colleagues. Senate work and responsibilities become part of their regular schedule. When a governance

representative is released from expectations and responsibilities from their job-related duties, they are provided time to attend meeting with no interruptions or job-related duties. In addition, they are provided additional time during their regularly scheduled hours to accomplish remaining work commensurate with hours and role (Senator, Committee Chair, SDC representative etc).

Comp time is hours worked beyond regularly scheduled hours on duties and responsibilities commensurate with role. Comp Time is recorded on timesheets and used in accordance with their CBA.

EA Contracts/Overtime are the final options for Professional/Classified staff for the hours specified by a governance representative's role in Senate. Hiring an EA to cover the time and duties for Professional/Classified staff requires the CEO's approval.
