 a. Final meeting of 2024, welcoming a full complement of senators spoke about collegiately and expectations, adding agenda items, open meeting expectations, campus shared governance, NECHE report and visit.

### 4. CT State President Remarks - John Maduko

- a. Post election concerns, DEI concerns, marginalized communities at CT State, funding, uncertainty and change, civility, board of regents meeting, CSCU healthcare taskforce, ACT framework and KPIs.
  - i. Ladders refer to creating pathways to transfer to charter oak.
  - ii. DACA students and figuring out what happens at the national level and what we as CT State and legislation can do.
  - iii. New Britain funds come from capital funds, not campus or operational funds.

### 5. CT State Reports

- a. Vice President Anna Krupitskiy
  - i. Presentation regarding Human Resources, campus visits, CT State Human Resources versus CSCU HR Shared Services, CT State HR organization chart, overview of feedback regarding shared services, gaps, and morale, next steps regarding website, centralized communication, and a 100 day assessment.
    - 1. Focus on onboarding and hiring, office of equitable and human rights supporting us, lack of consistencies in recruitment, Human Resources returning to CT State, education requirements being contractual and equivalencies, internal jobs and candidates, and addressing desires to not serve on search committees.
- b. Academic Restructuring Provost Karen Hynick
  - i. How the restructuring streamlines positions, saves costs from our previous model, roles of the new positions, working more effectively across our schools, national searches for positions. There was work done to divide the number of programs evenly between school deans. The no hiring edict of Governor Lamont should not stop this process from happening due to accreditation requirements, nor should it impact the NECHE visit.

## 8. Discussion Items

a. Committee Work Responding to Campus Reports

### i. Admin/HR

- 1. The primary task is evaluating the proliferation of committees and councils and the duplicity of this work at CT State and the need to make a recommendation to CT State leadership.
- 2. Continue to organize and understand the shared services issues.

## ii. Bylaws

1. The committee has met twice. Modified language but are now working at an organization to follow RRO.

### iii. Bookstore

 The committee has met twice. Four priorities: accessibility of books, availability of books, quality of control and communications regarding faculty book orders, time adoption and book contract and our vendor is meeting the needs of the community. February and March for recommendation endorsements.

# iv. Council of Faculty

1. Primary conversations revolved around issues regarding the provost's perspective, and feedback regarding what programs belong under what school.

### v. Council of Prof Staff

 The council has met twice. Derived 16 areas of focus and now identifying areas of focus to create subgroups. Worked with the website team for recommendations. Will we have recommendations put out in December.

### vi. Elections

 First meeting last month. Feedback about election cycles but there is little to do because of bylaws. Getting ready for the processes and methodology of new faculty senators in the Spring.

# vii. Enrollment Management

1. The group has met twice, course caps, and enrollment management. We want Transparency regarding course cancelling being sent to students and create a flow process for this.

# viii. Finance

- Finance committee morning early this week. Kerry Kelly came and we
  discussed BOR costs, CT State is awaiting official information regarding
  Lamont budget cuts, budget cuts can be covered by budget surplus. BOR
  has requested 5-year sustainability plan but relies on state support and
  tuition income. Bulk of deficit can be paid by reserves, but legislature
  will need to support us for fiscal stability. CT State budget spending
  hasn't been optimal, but revisions are being made to ensure wiser
  spending.
- ix. Shared Governance Assessment Joint Committee
  - 1. The committee adopted a timeline and reviewed feedback from the shared governance summit. A survey will be sent to the entire college soliciting additional information/feedback. The primary focus of feedback thus far has been related to Curriculum Congress, and we will collect more information about shared governance at CT State. The survey seeks to collect information and will benefit from wide participation and is going out 3<sup>rd</sup> of December and will close on the 20<sup>th</sup>. Proposals will come through Senate and will go to the campuses for endorsement
