## 3. Welcome: College Senate President Elle Van Dermark

a. Asked for feedback regarding drafts of recommendations and policies that are due at the end of next week, NECHE visit on April 6-8, delegation of College Senators met with Governor Lamont. They addressed morale, costs associated with being an open access institution and the need to fund Early College and Dual Enrollment, reliable funding model needed, meeting with President Maduko, and felt the meeting went well.

## 4. CT State President Remarks - President John Maduko

a. Updates regarding CT State:

- i. Federal, National, & State Developments: Executive order regarding US Dept. ED, Student Loan Portfolio, universities shuttering DEI divisions, and \$149 million cut from CT Department of Health. Additional overview of the Federal Funding CT State receives. CT State stands by our DEI mission and values but there maybe also be legal issues as federal policies escalate. There are strategies to get around this but emphasizes the need to be careful.
- ii. US Department of ED Dear Colleague Letter: there will be virtual town halls, and similar meetings for Campus Foundations.
- iii. CSCU & CT State: finalizing plans and schedule for Focused Visit, Tunxis opening the Advanced Manufacturing Technology Center, preparing response to proposed Shared Governance Changes, and lunch with Governor Lamont. Student humanitarian statuses are being revoked federally and there will be assessments to gauge the impact.

- b. Campus Leadership Restructure Sen. Asantewa Dawson
  - i. Motion to move into executive session to form a list of items to bring to CT State Management regarding the Campus Leadership Restructure. This needs to be done in executive session for individuals to express themselves freely without retaliation.

  - a. Sen. Elle Van Dermark determined there is not sufficient reason for Executive Session.
    - i. No appeal was made and the motion died.
- 2. Conversation and questions asked towards CT State management regarding the complexities of the identities of campuses, the president role, the role of program coordinators between what would now be two campuses, faculty unsure of having to teach now across two campuses, the speed of executing the changes without feedback, the need for the change given the costs we have saved and put into reserves, the positives behind campuses combining, concerns with campuses merging with a satellite campus, an ask of a year plan of the change, and will Danbury instructors belong to Danbury or another campus.
  - a. President John Maduko responded about how the adoption of the campuses presidents would save 1.2 million dollars annually when actualized, a reduction of administration, commonality of single administrators across multiple campuses, emphasis on no campuses being lost, development of the Danbury location, emphasizing the speed of hiring is his decision, prioritizing the funding of resources and services for our students, no president being pre-selected, and the need of us as CT State moving forward as one institution. Danbury, the community, has asked for a campus and the Danbury campus has a transitional plan of building out the personnel of staff and faculty. There will be a strategic plan discussion towards the end of the academic year.

#### c. Posthumous Degree: Proposed Procedures for CT State-Provost Karen Hynick

i. Draft policy given to senators to share out to award students who have passed before finishing a degree could have other individuals apply for a posthumous degree for them. Students need to have at least seventy-five percent completion in order to qualify for this.
